## **Proof of Identification**

You are required to show the accredited assessor original EOI documents that add up to at least 100 points. Certified copies will **not** be accepted. \*\*\* **NO ID WILL RESULT IN NO ASSESSMENT** \*\*\*

**NOTE:** <u>ID is your responsibility not the trainers or the assessor's</u>, if you do not bring correct ID the assessor will not test you. <u>Additional days incur additional cost</u>.

- The table below outlines the acceptable EOI documents and points value allocated to each document.
- The combination of EOI documents must contain **your date of birth, current nsw residential address, photograph and signature.**
- The documents you provide to the assessor generally should be the same documents you provide to the Australia Post customer service officer when lodging your Application for national licence to perform high risk work new application form (catalogue no. WC02084)
- If you use more than one credit card, savings account card or bank statement, they must be from different banks. (e.g. St George card and Commonwealth bank statement).
- If you use more than one utilities bill, they must be from different utilities providers.
- All documents provided <u>must contain your name in full, not just your initials</u>. The only exception is a council rates notice.
